## MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Agreement entered into this \_\_\_\_\_ day of FEB 20 2018, 2017, here at City of Malolos, Bulacan by and among:

The **PROVINCIAL GOVERNMENT OF BULACAN**, a public corporation established in accordance with existing laws, with office address at the Provincial Capitol Building, City of Malolos, Bulacan, and herein represented by its Provincial Governor, **HON. WILHELMINO M. SY-ALVARADO** and herein referred to as "PGB";

-and-

The **DEPARTMENT OF EDUCATION -DIVISION OF BULACAN**, an agency providing quality basic education to Bulakenyo youths, with office address at Provincial Capitol Compound, City of Malolos, Bulacan and herein represented by **DR. ROMEO M. ALIP, Ph. D., CESO V** and hereinafter referred to as the "DepEd Bulacan";

-and-

The **BULACAN MOVEMENT FOR RESPONSIBLE PARENTHOOD INCORPORATED (BMRPInc.)** a movement that seeks to strengthen the Bulakeño families, and hereinafter represented by its Chairperson, **BISHOP EDILBERTO D. CHAN** and hereinafter referred to as "BMRP";

### WITNESSETH: That

WHEREAS, PGB, pursuant to its noble mandate as stated in Article II, Section 12 of the Philippine Constitution, recognizes the sanctity of family as a basic autonomous social institution;

WHEREAS, PGB needs the support of the other government agencies, people's organization and non-government organization to carry-out the mission to strengthen the Bulakeño family, primarily by enhancing the competencies of parents to discharge their responsibilities to family;

WHEREAS, DepEd Bulacan is a government agency with the primordial task of educating every Bulakeno child;

WHEREAS, the BMRP Inc. is willing to extend assistance through its significant and valuable teachings about strengthening family ties and being God fearing Bulakeños;

NOW, THEREFORE, for and in consideration of the foregoing, parties herein mutually agree of the following terms and conditions:

**I. The Project**

The Parent Teachers Association- Hahging Organisasyon ng mga Magulang sa Elementarya at Sekundarya (PTA-HOMES) is a joint undertaking of the PGB, with BMRP, DEP-Ed Bulacan and Non Government Organizations that seeks to strengthen the Bulakeño family primarily by enhancing the competence of parents to discharge the responsibilities of family.

**II. Vision:**

That Bulacan be a productive, progressive, and peaceful province through its unified and strong families, whose members are role of excellence in integrity and godliness, key factors in making the province the best place to live in.

**III. Mission:**

Toward this end, the parties are committed to:

- 1.) Develop strong Bulakeño families whose members are united, loving, and stable amidst diverse trials in life, buoyed by their faith in God, the foundation of victorious living.
- 2.) Develop responsible family members who are committed to do their individual responsibilities at home;
- 3.) Teach Bulakeño families to have reverential fear and love of God, that they may experience His blessings and abstain from evil practices and wrong doings, resulting in clean and healthy family living.
- 4.) Teach parents how to rear their children and how to discipline them as well, to produce youth who will be hope of Bulacan; and
- 5.) Promote to parents the importance of providing for their families

**IV. Responsibilities of the Parties**

**A. The Provincial Government of Bulacan (PGB) through the Provincial Administrator shall:**

- 1.) Be responsible for all the communications to all concerned agencies and school principals and the Public Schools District Supervisors through the Office of the School Division Superintendent, where the seminars will be conducted. Thus, this includes the task of requesting the necessary permit to conduct the seminar.
- 2.) Provide funds to BMRPInc., as specified in their Annual Investment Plan submitted every year.

**B. The Department of Education- Division of Bulacan (DepEd Bulacan) shall:**

- 1.) Disseminate the provisions stipulated in this Memorandum of Agreement to all DepEd Supervisors and other concerned personnel, and ensure its strict implementation;
- 2.) Instruct school principals to assign a teacher for each level to handle the registration of participants during seminars;
- 3.) Take charge of registration and submit the list of participants to the Lecturer and to the School Principal for follow-up and report preparation. Reports shall be submitted to the PTA-HOMES office.
- 4.) Direct the School Principals to communicate with the officials of PTA HOMES-BMRP Inc., the schedules of the distribution of Form 138 for the entire school year through the Office of the School Division Superintendent.

This will ensure the teaching of Modules I to V to all parents. This will likewise assist PTA HOMES-BMRP in planning the schedules of seminar ahead of time.



**C. Bulacan Movement for Responsible INC. (BMRPI) shall:**

1. Be In-charge of managing PTA-HOMES program of the province.
2. Consolidate Dep-Ed reports and prepare progressive report of the program that will be submitted to the Office of the Provincial Administrator.
3. Have its office open for counseling on marital, parenting and related concerns during office hours (8:00-5:00 pm), Monday to Friday.

**V. Term of the Contract**

This Agreement shall remain in full force and effect for a period of three (3) years, subject to renewal based on the agreement of the contracting parties.

**VI. Effectivity**

This Agreement shall take effect immediately upon being signed by the contracting parties.

## VII. Changes, Amendments and Revisions

Any changes or modifications in the provisions of this Agreement shall be made in writing, duly signed and confirmed by the parties.
