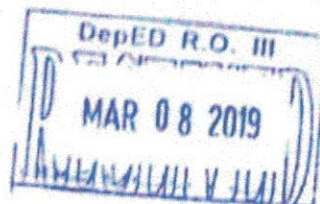

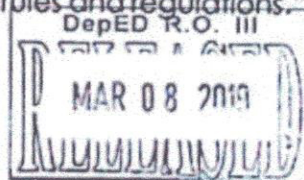
By attending this convention and seminar, they could be updated and keep abreast with the current development that could help them effectively perform their roles in their areas of responsibility.

The registration fee is **EIGHT THOUSAND PESOS (P8,000.00)** per participant for the 4-day conference. Pursuant to DBM Circular No. 563 dated April 22, 2016, payments of this nature including incidental expenses are chargeable against the agency funds.

Delegates shall pre-register on-line through the link that is to be announced in the GACPA Facebook account not later than March 15, 2019. Registrants should upload a copy of the deposit slip/LDDAP/ADA when pre-registering on-line and need not send them through fax or email. Pre-registered delegates will receive an email that the pre-registration for the 41st ANC has been accepted. Delegates should print the PDF ticket attached to the email and present this on May 22, 2019. Issuance of Convention Kit is on a "first come first served basis." The deadline to register with payment is **not later than April 27, 2019.** GACPA reserves the right to refuse the registration of walk-in participants who may no longer be accommodated in the venue.
