Resumption of Screening and Accreditation of Athletes, Coaches, Assistant Coaches and Chaperons for the 2020 Central Luzon Regional Athletic Association (CLRAA) Meet

1. In compliance with DepEd Memorandum No. 015, s. 2020 "First Set of Policy Directives of the DepEd Task Force nCOV", the screening and accreditation of athletes and coaches was suspended as stipulated in paragraph 2 of the Regional Memorandum No. 50, s. 2020 "Postponement of 2020 Central Luzon Regional Athletic Association (CLRAA) Meet.
2. With the issuance of DepEd Memorandum No.023, s. 2020 "Third Set of Policy Directives of the DepEd Task Force COVID-19", units at Central Office, Regional Offices, Schools Division Offices (SDOs) and schools may already resume the conduct of activities starting February 24, 2020. Thus, the screening and accreditation of athletes, coaches and chaperons will resume on March 16, 2020 in the Schools Divisions where screening and accreditation was not yet conducted.
3. It is advised that all personnel involved in the activity shall follow applicable measures contained in DM 015, s. 2020 and DM 021, s. 2020 "Second Set of Policy Directives of the DepEd Task Force NCoV".
