**Invitation to Bid for CY 2019 BEFF Repair of Classrooms
at Baras Bakal Elementary School

1. The Department of Education – Schools Division Office of Bulacan, through the Savings of CY 2019 – Basic Education Facilities Fund (BEFF)¹ intends to apply the sum of **ONE MILLION THREE HUNDRED ELEVEN THOUSAND SEVEN HUNDRED FORTY FOUR AND 88/100 (₱ 1,311,744.88)** being the Approved Budget for the Contract (ABC) to payments under the contract for the project **CY 2019 BEFF Repair and Maintenance of Classrooms at Baras Bakal Elementary School**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bids received in excess of the ABC for each lot shall be rejected at bid opening. Late bids shall likewise be rejected.

Pursuant to ITB 6.9, the Procuring Entity will accept bids only from those bidders who have paid the applicable fee for the Bidding Documents.

2. The DepEd – Schools Division of Bulacan through its Bids and Awards Committee (BAC) now invites bids for the above-mentioned works.² Completion of the Works is required within **ONE HUNDRED TWENTY Calendar Days (120 C.D.)**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instructions to Bidders.

¹ In the case of National Government Agencies, the General Appropriations Act and/or continuing appropriations; in the case of GOCCs, GFIs, and SUCs, the Corporate Budget for the contract approved by the governing Boards; in the case of LGUs, the Budget for the contract approved by the respective *Sanggunian*. 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from Department of Education – Schools Division Office of Bulacan and inspect the Bidding Documents at the address given below from 8:00 A.M. to 3:00 P.M.

A complete set of Bidding Documents may be acquired by interested bidders on the date and address specified below accomplishing a bidder’s information sheet and payment in cash of a non-refundable applicable fee in the amount specified above to the DepED – SDO Bulacan Cashier.

4. The Department of Education-Schools Division of Bulacan will hold a Pre-Bid Conference on November 4, 2020 at 10:00 A.M. at Conference Hall, 3rd Floor SDO Building, City of Malolos, Bulacan which shall be open to prospective bidders.
5. Bids must be duly received by the BAC Secretariat at the address below on or before November 17, 2020, 10:00 am. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
6. Bid opening shall be on November 17, 2020, 10:00 AM at DepEd – **Schools Division Office of Bulacan, City of Malolos**. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

Health protocols such as wearing of face masks and face shields at all times and social distancing in compliance to Department of Health and Inter-Agency Task Force Guidelines shall be strictly observed.

The *DepED – Schools Division of Bulacan* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
