The Department of Education-Schools Division of Bulacan through the School Based Feeding Program Fund SY 2020-2021 intends to apply the sum of Fourteen Million Two Hundred Ninety-Seven Thousand Forty Pesos only (Php 14,297,040.00) being the ABC to payments under the contract for *Provision of Food Commodities under the School Based Feeding Program for Kindergarten to Grade II Pupils of SDO Bulacan-SY 2020-2021*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Delivery of the Goods is required by *twenty (20) school days to commence immediately after approval of contract*. Bidders should have completed, within *one year* from the date of submission and receipt of bids, a contract similar to the Project. 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **November 3, 2020 at 10:00 A.M** at the given address below Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
