Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The Department of Education-Schools Division of Bulacan now invites bids for the above Procurement Project. Delivery of the Goods is required within contract duration (15 calendar days). Bidders should have completed, within two years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from Department of Education-Schools Division of Bulacan and inspect the Bidding Documents at the address given from 8:0A.M. to 3:00 P.M. A complete set of Bidding Documents may be acquired by interested Bidders on

December 9, 2020 until the date of submission of bids from the given address and website(s) below.

- 6. The Department of Education-Schools Division of Bulacan will hold a Pre-Bid Conference on December 16, 2020 at 10:00 A.M. at Conference Hall, 3<sup>rd</sup> Floor SDO Building, City of Malolos, Bulacan which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before *December 28, 2020 at 11:00 A.M.* Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on *December 28, 2020 at 11:01 A.M.* at the given address below Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The Department of Education-Schools Division of Bulacan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
