- The Department of Education-Schools Division of Bulacan now invites bids for the above Procurement Project. Delivery of the Goods is required by within *ten (10) calendar days of contract duration*. Bidders should have completed, within *two years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary *"pass/fail"* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183. Prospective Bidders may obtain further information from Department of Education-Schools Division of Bulacan and inspect the Bidding Documents at the address given below during *8:00 A.M. to 3:00 P.M.* A complete set of Bidding Documents may be acquired by interested Bidders on **December 9, 2020** from the given address and website(s) below.
