2. The Department of Education-Schools Division of Bulacan now invites bids for the above Procurement Project. Delivery of the Goods is required *within contract duration (15 calendar days)*. Bidders should have completed, within *two years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
5. Prospective Bidders may obtain further information from Department of Education-Schools Division of Bulacan and inspect the Bidding Documents at the address given from *8:00 A.M. to 3:00 P.M.* A complete set of Bidding Documents may be acquired by interested Bidders on December 9, 2020 until the date of submission of bids from the given address and website(s) below.
6. The Department of Education-Schools Division of Bulacan will hold a Pre-Bid Conference on *December 16, 2020 at 9:00 A.M.* at Conference Hall, *3<sup>rd</sup> Floor SDO Building, City of Malolos, Bulacan* which shall be open to prospective bidders.


