  - (ii) Thirty percent (30%) of the total contract price in the form of surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security.

- d. PERT/CPM Diagram
- e. Manpower Utilization Schedule
- f. Construction Method
- g. Equipment Utilization Schedule
