WHEREAS, the Department of Education (DepEd) Schools Division of Bulacan conducted procurement for the **CY 2020 Basic Education Facilities Fund for Repair of Classrooms at Padling Elementary School** with an amount of **FOUR MILLION NINE HUNDRED NINE THOUSAND FIVE HUNDRED TWENTY FIVE AND 19/100 (Php 4,909,525.19)**, being the Approved Budget for the Contract (ABC).

WHEREAS, on September 4, 2020, the BAC Secretariat posted the Invitation to Bid for the said project at the PhilGEPS through <http://bulacan@deped.gov.ph> with Project No. PB-20-09-010 as its reference number and on conspicuous places within the Schools Division Office premises, copy of the Invitation is attached and marked as Annex "B";

WHEREAS, sixteen (16) prospective bidders acquired Bidding Documents for this activity which were made available starting September 15, 2020;

WHEREAS, the Pre-Bid Conference was held on **September 15, 2020 at 9:00 A.M.** through **Google Meet** (<https://meet.google.com/nfj-gtuz-ets>) wherein important matters pertaining the competitive bidding and the rudiments of its conduct were discussed with prospective bidders and representatives of some bidders, with the end users and observers in attendance, minutes of the meeting is attached and marked as Annex "C";

WHEREAS, during the submission and opening of sealed bids held at the 3<sup>rd</sup> Floor Conference Hall, DepEd Division Office, City of Malolos on September 28, 2020, 1:00 PM, seven (7) bidders submitted their bids, copies of the Minutes of Bid Opening, Abstract of Bids As Read and Checklist for Bid Opening are attached and marked as Annexes "D", "E"; and "F", respectively;

WHEREAS, in order to determine the Lowest Calculated Bid, Detailed Evaluation and Comparison of Bids was held on October 1-8, 2020, copy of the Evaluation Report and the Abstract of Bid as Calculated are hereto attached and marked as Annexes "G" and "H" respectively;

WHEREAS, per post qualification of bid to determine if the lowest offeror complied and was responsive to all requirements and conditions of the contracts, as evidenced from the hereto attached post qualification report marked as Annex "I", the offeror met all the requirements for the Contract and the bid was declared as the Lowest Calculated and Responsive Bid;
