### Recommending Award of Contract to Kosmos Technomobile, Inc. for the Re-bid of Purchase and Delivery of Tablet Units for SDO Use (Project No. PB 20-027)

WHEREAS, on December 16, 2021, the Department of Education Schools Division of Bulacan through the Bids and Awards Committee (BAC) posted an Invitation to Bid¹ (Annex A) for the rebid of Purchase and Delivery of Tablet Units for SDO Use at the PhilGEPS with Reference Number 7361292²(Annex B), a one lot project with an ABC of One Million Two Hundred Seven Thousand pesos (Php 1,207,000.00).

WHEREAS, a pre-bid conference<sup>3</sup>(Annex C) was held on December 22, 2020 at 10:30 o'clock in the morning, attended by the Bids and Awards Committee, TWG, BAC Secretariat and two potential bidders, during which the standardized public bidding procedure was discussed and the needed modification of the technical specifications required of the project had been finalized and in which it was agreed that a Supplementary Bid Bulletin<sup>4</sup>(Annex D) to provide clarifications to all potential bidders regarding the modifications on technical specifications of the units to be procured shall be issued;

WHEREAS, only one (1) interested bidder acquired the bidding documents, Kosmos Technomobile, Inc. and submitted its offer during the opening of bid on January 4, 2021;

WHEREAS, Kosmos Technomobile Inc, passed the assessment of both the technical and financial eligibility requirements as expressed in the Abstract of Bids as Read<sup>5</sup> (Annex E);

WHEREAS, upon bid evaluation and post qualification<sup>6</sup> (Annex F), the bid of Kosmos Technomobile Inc. was declared "responsive";

NOW, THEREFORE, based on the above premises, WE, the members of the Bids and Awards Committee, hereby RESOLVE as it is RESOLVED to recommend the award to :
