

**LIMITATION TO CLAIMS FOR THE  
MONETIZATION OF LEAVE CREDITS (MLC)**

To : All Schools Division Superintendents  
All Regional Office Personnel

1. This is in reference to the letter from ISABEL C. TAGUINOD, Director IV of Department of Budget and Management (DBM), dated March 2, 2021, relative to the numerous requests for the release of funds to cover Monetization of leave Credits (MLC) of the various Schools Division Offices of Region III.
2. This Office was informed that although MLC of the national government may be charged against the FY 2021 Pension and Gratuity Fund ( RA No.11518), said fund was significantly reduced in the FY 2021 Budget. Therefore, to ensure that the FY 2021 PGF appropriations can fully provide for the RG and TL requirements of retirees which should be considered as first priority, approval for the payment of MLC shall be limited to claims for **critical health, medical, and hospital needs of government employees and immediate members of their families.**
3. In view of the foregoing, Schools Division Superintendents are advised to strictly adhere to the conditions set forth for the prioritization on the approval of request for monetization of Leave Credits (MLC).
4. Wide dissemination of this memorandum is desired.

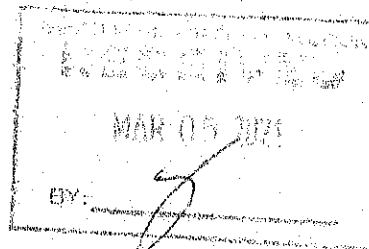
