**Invitation to Bid for**  
**Project No. PB-21-032 – Repair and Rehabilitation of Classrooms**  
**at Assemblywoman Felicita G. Bernardino Memorial Trade School,**  
**Marilao, Bulacan**

1. The **Department of Education – Schools Division of Bulacan**, through the **General Appropriations Act (GAA) 2021 – Basic Education Facilities Fund (BEFF)** intends to apply the sum of **THREE MILLION TWO HUNDRED SIXTY ONE THOUSAND EIGHT HUNDRED EIGHTY NINE AND 39/100 PESOS (Php 3,261,889.39)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Project No. PB-21-032 - Repair and Rehabilitation of Classrooms at Assemblywoman Felicita G. Bernardino Memorial Trade School, Marilao, Bulacan**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Department of Education – Schools Division of Bulacan** now invites bids for the above Procurement Project. Completion of the Works is required **120 calendar days upon receipt of Notice to Proceed**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Department of Education – Schools Division of Bulacan** and inspect the Bidding Documents at the address given below from **8:00 am to 4:00 pm**.
5. A complete set of Bidding Documents may be acquired by interested bidders on the date and address specified below accomplishing a bidder’s information sheet, payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount of **five thousand Pesos (P5,000.00)** to DepEd – SDO Bulacan Cashier.


