WHEREAS, the Department of Education (DepEd) Schools Division of Bulacan conducted procurement for the **CY 2021 BEFF Repair and Rehabilitation of Classrooms** at **Partida HS (San Miguel NHS - Partida HS)** with an amount of **THREE MILLION SEVEN HUNDRED TWENTY EIGHT THOUSAND THREE HUNDRED NINETY ONE AND 26/100 (Php 3,728,391.26)**, being the Approved Budget for the Contract (ABC).

WHEREAS, copy of Authority to Procure is attached and marked as Annex "A";

WHEREAS, on July 13, 2021, the BAC Secretariat posted the Invitation to Bid for the said project at PhilGEPS with Reference No. 7838888, through <http://bulacandeped.com> and on conspicuous places within the premise, copy of the Invitation is attached and marked as Annex "B";

WHEREAS, nine (9) prospective bidders acquired Bidding Documents for this activity which were made available starting July 14, 2021;

WHEREAS, the Pre-Bid Conference was held on **July 22, 2021 at 9:00 A.M.** through **Google Meet** (<https://meet.google.com/pnc-snr-ymb>) wherein important matters pertaining the competitive bidding and the rudiments of its conduct were discussed with prospective bidders and representatives of some bidders, with the end users and observers in attendance, minutes of the meeting is attached and marked as Annex "C";

WHEREAS, during the submission and opening of sealed bids held at the 3rd Floor Conference Hall, DepEd Division Office, City of Malolos on July 14, 2021, 9:00 AM, eight (8) bidders submitted their bids, copies of the Minutes of Bid Opening, Abstract of Bids As Read and Checklist for Bid Opening are attached and marked as Annexes "D", "E"; and "F", respectively;

WHEREAS, in order to determine the Lowest Calculated Bid, Detailed Evaluation and Comparison of Bids was held on August 6-24, 2021, copy of the Evaluation Report and the Abstract of Bid as Calculated are hereto attached and marked as Annexes "G" and "H" respectively;

WHEREAS, per post qualification of the bid the lowest offeror failed to meet the requirements and conditions, as they failed to indicate price on the following items: a. General Requirements (Fire Safety Inspections Certificate, Other Permit Fee, Hauling Cost); b. Bldg# 3 FFCCCII Bldg 1STY2CL (5.5mms THW Wire, Stranded); and c. Bldg. # 4 DepEd Standard BLDG 4STY8CL (5.5mm² THW Wire, Stranded) which is considered required item that need to be provided, but no price is indicated and shall be considered as non-responsive. Also the second lowest offeror failed to sign each and every page of the Bill of Quantities and thereby declared post-disqualified.
