

MONITORING AND EVALUATION (M&E) ON THE IMPLEMENTATION OF THE MOST ESSENTIAL LEARNING COMPETENCIES (MELCs) OF THE SPECIAL EDUCATION (SPED) AND THE SPECIAL CURRICULAR PROGRAMS (SCPs)

To: Schools Division Superintendents

- 1. The Bureau of Curriculum Development (BCD), through the Special Curricular Programs Division (SCPD), shall monitor and evaluate the implementation of the most essential learning competencies (MELCs) of the Special Education (SPED) Program and the Special Curricular Programs (SCPs) namely: Special Program in the Arts (SPA), Special Program in Foreign Language (SPFL), Special Program in Journalism (SPJ), Special Program in Sports (SPS), Special Science Program (SSP), and Special Program in Technical-Vocational Education (SPTVE).

The M&E activity shall be undertaken in reference to item no. 6 of DepEd Order No. 12, s. 2020 entitled Adoption of the Basic Education Learning Continuity Plan (BE-LCP) for School Year (SY) 2020-2021 in Light of COVID-19 Public Health Emergency where the Curriculum and Instruction (CI) Strand is directed to monitor the implementation of the MELCs and evaluate its effectiveness in consultation with the regional directors. Ultimately, a report shall be submitted to the Office of the Secretary that shall be used to enrich the ongoing curriculum review. The M&E is intended for teachers and school heads of SPED and SCP implementing schools. It is national in scope as it will cover the seventeen
