

Pursuant to Proclamation No. 1667, s. 2008 declaring November 19 to 25 of every year as the National Climate Change Consciousness Week, the Department of Education (DepEd) through the Disaster Risk Reduction and Management Service (DRRMS) reaffirms its commitment in strengthening the *makakalikasan* value of learners and personnel, especially in the light of biodiversity conservation and climate change.
