The Child Rights in Education Desk (CREDe), under the Office of the Undersecretary for Legal Affairs (OULA), is pleased to invite you to the **Third National Summit on the Rights of the Child in Education (CREDe) on November 25 to 26, 2021, every 1:00 p.m. to 4:00 p.m. via Zoom platform and DepEd Philippines Facebook Live.** This event will serve as a culminating activity for the National Children's Month this November, as stated in DepEd Memorandum (DM) 080, s. 2021.

With the theme, *Batang May K: Karapatan ng Bata sa Edukasyon, Kasama ang Lahat sa Pagsulong!*, the Third Summit aims to reinforce the continuing commitment of the DepEd and various stakeholders in upholding children's rights in education in normal times and during the COVID-19 pandemic. It aims to build on the gains of the Second National Summit on the Rights of the Child in Education held last November 2020, and to introduce the rights-based education (RBE) framework of DepEd and the newly created Child Rights in Education Desk (CREDe).

The Third National Summit seeks to facilitate discussions and elicit recommendations on upholding RBE in normal times and during the COVID-19 pandemic through a whole-of-school, whole-of-DepEd, whole-of-government, and whole-of-society approach. It is also a venue to ensure the participation of children in shaping policies and actions pertaining to RBE in normal times and during the COVID-19 pandemic.

As stated in DM 080, s. 2021, all regional directors (RDs), schools division superintendents (SDSs), and Central Office Directors of Bureaus and Services shall submit their list of participants by accomplishing our registration form via this link: <https://tinyurl.com/ThirdNationalSummit> on or before November 24, 2021. Please be informed that only the registered participants will be pre-assigned prior to the Summit to one of the break-out/parallel sessions on Day 2 of the Summit.

For those who wish to join but are not identified as participants who can register within Zoom under DM 080, s. 2021, you are most welcome to join in the event as the Third National Summit will be streamed live via the DepEd's Facebook page (<https://www.facebook.com/DepartmentOfEducation.PH>) on the actual days of the Summit.

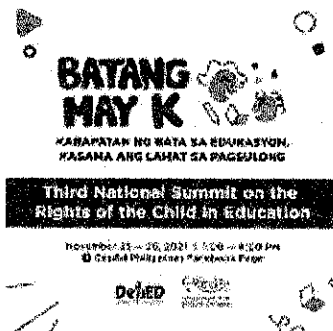
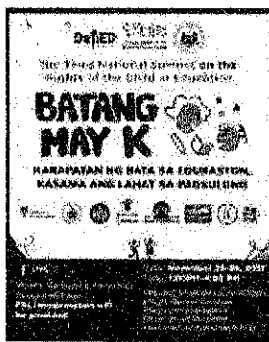
