DIVISION ORIENTATION AND WORKSHOP ON THE AGENCY SELECTION/ PROMOTION PROCESS AND CSC POLICIES ON APPOINTMENTS AND PROGRAM TO INSTITUTIONALIZE MERITROCRACY AND EXCELLENCE IN HUMAN RESOURCE MANAGEMENT (PRIME-HRM)

- 1. Pursuant to the Rule X of the 2017 Omnibus Rules on Appointments and Other Human Resource Actions (ORAOHRA) revised 2018, this Schools Division Office will conduct an orientation and workshop on the selection/promotion process and CSC policies on appointments for the HRMPSB Members and Alternate Representatives on January 8, 2020 at 8:00-5:00 at the SDO Conference Hall. There will also be a review of the PRIME-HR.
- 2. This activity aims to:

2.1 orient the HRMPSB on the 2017 ORAOHRA revised 2018;

2.2 prepare the HRMPSB Manual which contains the salient points of the ORAOHRA and the criteria for the selection process, scores to be given to applicants for each criterion, and required documents for the selection, promotion and reclassification of teaching and teaching related, non-teaching personnel, and principals and head teachers.

2.3. discuss the CSC MC No. 14, s.2020 titled "Interim Guidelines on Appointments and Other Human Resource Actions for the Period of State of Calamity Due to COVID 19 Pandemic and craft the SDO's IGAOHRA.

2.4 review and assess the implementation of PRIME-HR in the SDO.
