  - e. Performance Rating for three (3) consecutive rating periods
  - f. Certificates, MOVs and other documents determinants (A-H) for ranking of Master Teacher
- Pre-evaluation template should be accomplished and submitted together with the Letter of Intent by the Public Schools District Supervisor two (2) days prior to the virtual division open ranking. (Enclosure No. 2).


