- e. Performance Rating for three (3) consecutive rating periods
- f. Certificates, MOVs and other documents determinants

8. The Schools Division Superintendent must be furnished with the copy of the result and should be posted in three (3) conspicuous places.

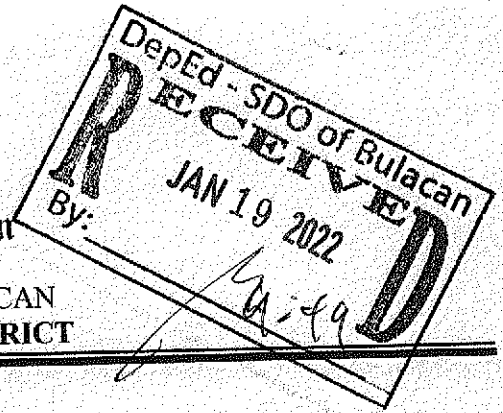


