TERMS OF REFERENCE OF SCHOOL HEALTH AND NUTRITION UNIT FOR SY, 2021-2022

- 1. This is to reiterate the Office Functions of the personnel from the School Health and Nutrition Unit, the medical officer, nurses, dental officers and dental aides, pursuant to the statement of the purpose laid out by the Office, through the School Governance and Operations Division (SGOD) and to strengthen the capability of schools to create an environment conducive to teaching and learning, provide for the holistic development of learner and ensure their readiness to learn through the timely planning, mobilization and equitable distribution of sufficient resources, development of human resources, provision of technical assistance and building strong partnership with stakeholders for increased support and resources to effectively and efficiently implement sustainable programs, projects and services leading to increased access to and delivery of basic education.
- 2. In addition, they are expected to assist the school heads, teachers, and learners in addressing challenges of health crisis brought by the COVID 19 pandemic and ensure the readiness and safety of school facilities in preparation for the implementation of health programs.
- 3. School Health and Nutrition personnel are expected to attend the flag raising ceremony every Monday morning and flag lowering every Friday afternoon.
- 4. Deployment scheme at the Division Office should consider availability of school health and nutrition unit daily to ensure provision of health services to employees and staffs.
- 5. Public Schools District Supervisors, and Elementary and Secondary School Heads are hereby encouraged to give the necessary assistance to ensure full implementation of the School Health, Nutrition and Dental Programs within the Schools Division.
- 6. Attached are Enclosure No. 1, list of district assignments of school health personnel, and Enclosure 2, Office Functions personnel from the School Health Unit.

Office Functions of the Personnel from the School Health Unit

Medical Officer

- Plan and formulate policies strategies and guidelines on Health and Nutrition Programs of the Schools Division Office;
- Monitor and evaluate the implemented School Health and Nutrition Programs of the Schools Division
 Office for the direct benefit of the learners;
- · Prepare and submit periodic reports of accomplishment;
- Monitor, evaluate and report the Nutritional Status of learners;
- Develop, design, Implement, monitor, evaluate and report sustainable feeding programs for the identified severely wasted and wasted learners of the Schools Division Office;
- Ensure implementation and compliance of nutrition programs to Nutritional Standards in Food Preparation; and
- Establish, maintain, and sustain partnerships and agreements with other agencies and stakeholders in accordance with DepEd Established Standards for Health and Nutrition Programs.

Dentist

- Plan and implement policies and guidelines pertaining to Dental Health Programs of the Schools Division:
- Develop, design, implement, monitor, evaluate, and report sustainable dental health programs for all learners of the Schools Division;
- Prepare and submit periodic reports of accomplishments in the implementation of Dental Health Care Programs;
- Monitor and evaluate the implemented School Dental Health activities in support of Nutrition Programs that directly benefit the learners of the SDO;
- Prepare and submit report on Dental Health Status of learners in the SDO; and
- Establish and maintain partnerships and agreements with other agencies and stakeholders following the DepEd Standards for Dental Health and in direct support of all Nutrition Programs in the SDO.

Nurses

- Conduct classroom inspection to detect early signs and symptoms/disability of learners;
- Assist the Medical Officer in doing school clinic works such as vital signs taking, RBS monitoring, immunizations, etc.;
- Provide preventive and remedial measure for simple and common ailments and give first aid treatment in the school;
- Conduct visual and auditory screening, height and weight measurement, and deworming of learners;
- Maintain functional school clinics;
- Check on the proper sanitation and healthful living conditions of the school and community;
- Utilize tried and tested medicinal plants for the treatment of common ailments;
- Coordinate with other health personnel in the translation of scientific knowledge to desirable health behavior:
- Coordinate with the medical officer for the provision of the needed health facilities, medicine and other related supplies;
- Prepare and submit all reports being required for submission;
- Assist in the development, design, implementation, monitoring, and evaluation of sustainable feeding programs for the identified severely wasted and wasted learners within the Schools Division, and submit the needed reports;
