DIVISION ONLINE TRAINING ON THE CONTEXTUALIZATION OF THE CURRICULUM FOR INDIGENOUS PEOPLES EDUCATION (KINDERGARTEN AND GRADE 1 MTB-MLE LEARNING ACTIVITY SHEETS)

1. In consonance to the Enhanced Basic Education Program, as stipulated in RA Act No. 10533 and the IPED provisions of its implementing Rules and Regulations (Sec. 8.4), mandates DepEd to develop a curriculum that is culture-sensitive, contextualized and flexible enough to enable and allow schools to localize and indigenize based on the social context of indigenous cultural communities (ICCs). In support of this mandate, DepEd SDO-Bulacan, will conduct the Online Division Training on the Contextualization of the Curriculum for Indigenous Peoples Education (Kindergarten and Grade 1 MTB-MLE Learning Activity Sheets) on November 9-12, 2021 at 8:00 am -5:00 pm.
2. In this training, participants are expected to develop a holistic perspective on the overall learning and socio-cultural context of ICCs. In particular, participants are expected to contextualized Kindergarten and Grade 1 MTB-MLE Learning Activity Sheets (LASs) culturally responsive to the ICCs being served based on the Kindergarten and Grade 1 Most Essential Learning Competencies (MELCs).
3. Participants of this training-workshop are Division IPED program focal persons, division IPED Program alternate focal persons, division LR supervisor, division MTB-MLE supervisor, language reviewers, IP culture bearers, illustrators, lay-out artists and teacher-writers in each grade level (Kindergarten and Grade 1) who have IPED trainings and orientation or have been immersed in ICCs and gained IP perspective.
4. Each IP Implementing school is expected to prepare their contextualized competencies, copy of school IPED Framework, orthography, the documented indigenous knowledge systems and practices (IKSPs) from the ICC being served, copy of Kindergarten and Grade 1 MELCS and laptops. Each IPED implementing divisions is requested to submit the quality assured Kindergarten and Grade 1 Learning Activity Sheets after the training.
