To; CID and SGOD Chiefs, PSDS, Public Secondary School Heads All Others Concerned


- 1. The challenge of experimenting with new mobile technological innovations for teaching and learning is a constant factor for teachers at present. The application of mobile learning are boundless, and mobile phones are now becoming the most commonly used devices among students, the rapid and recent development of mobile Apps for teaching purposes with mobile phones are growing on a daily basis, this Office announces the conduct of a 3 day Division Training Workshop on the Technological Innovation on the use of Mobile Apps for Teaching and Learning on September 25-27, 2019. - 2 The objectives of this training workshop are to:
 - a.) provide a well-balanced learning environment that meets the current digital learner's needs;
 - b.) support learning experiences that are collaborative, portable, flexible, easily, accessible: and
 - c.) integrate with the world globally, beyond the traditional classroom.
- 3. The participants for this training are (1) ICT Teacher Representatives per District and (1) ICT Teacher per Secondary School and 8-Resource Speaker, 4-Facilitator and 3-Technical Working Group.
- 4. The participants are expected to bring the following:
 - a. laptop
 - b. smart media phone
 - c. internet connectivity
 - d. extension cords
- 5. The list of schools, participants, training matrix, and speakers/facilitators/technical working committees are enumerated in Enclosure No. 1 of this memorandum
- 6. All expenses to be incurred in the conduct of the training -workshop shall be charged against the Division INSET Fund, while the transportation allowance of the participants shall be charged to local school funds subject to usual accounting and auditing rules and regulations.
- 7. The memorandum also serves as travel authority of the participants, resource speakers and the members of the technical working group.
- 8. It is desired that the content of this this Memorandum be given wide dissemination.
