

**80TH ARAW NG KAGITINGAN AND PHILIPPINE VETERANS WEEK
CONTEST MECHANICS
ESSAY WRITING CONTEST**

1. Background and Objectives

In celebration of the 80th *Araw ng Kagitingan* and Philippine Veterans Week, the Department of Education (DepEd), Philippine Veterans Affairs Office (PVAO), and the Department of National Defense (DND) are sponsoring an Essay Writing Contest.

The objective of the contest is to increase awareness of the *Araw ng Kagitingan* as a shining moment of courage and commitment to freedom by our World War II (WWII) veterans.

2. Participants

The contest is open to all Grades 7, 8 and 9 students enrolled in any public and private secondary schools nationwide. The school should be duly recognized by DepEd. Previous winners of all the Special Events Unit (SEU) organized contests are not qualified to join to give chance to others.

3. Scope/Theme

The entries should depict the life, works and heroism of our Filipino heroes who fought for our country and should be in line with this year's theme: "**KAGITINGAN NG MGA BETERANO, INSPIRASYON NG NAGKAKAISANG PILIPINO.**"

4. Content

The entry must be a true to life story of the veteran/s (alive or deceased). The story teller must be his/her relative up to the 4th degree of consanguinity.

5. Entry Specification

The essay must be crafted from the story of the veteran/s. It should:

- 5.1 be written in Filipino
- 5.2 be typewritten in an A-4 bond paper
- 5.3 have single line spacing
- 5.4 have one (1) inch margin on both sides
- 5.5 use Times New Roman, font size 12
- 5.6 have a minimum of three (3) pages and a maximum of four (4) pages.
- 5.7 cite the name(s), address, telephone number/s (if any) of the veteran interviewed at the end of the essay

6. Criteria

- 6.1 Substance and Originality ----- 50%

7. Determination and Announcement of Winners

The contestant who will get the highest score shall be considered as the National Champion, the contestant with the second highest score shall be declared as the first runner-up, and the third highest shall be declared as the second runner-up, so on and so forth.

The names of the winners and process on claiming their prizes will be announced during the symposium.

8. Submission of Entries

8.1 The deadline for the submission of entries will be on **March 31, 2022** at **5:00 p.m.** Submission beyond the stated time shall be disqualified.

8.2 Only five (5) entries **PER DIVISION** are allowed. Each entry must be accompanied by the following requirements:

8.2.1 Endorsement from the Schools Division Superintendent (SDS) or the Chief of the School Governance and Operations Division (SGOD).

8.2.2 A certification from the school principal that the contestant is enrolled in the current School Year (2021-2022).

8.3 The entry shall be submitted together with all the requirements to anna.awa002@deped.gov.ph . Submission(s) with incomplete requirements will be disqualified.

**80th ARAW NG KAGITINGAN AND PHILIPPINE VETERANS WEEK
CONTEST MECHANICS
SONG WRITING CONTEST**

Subject to such changes as may be determined appropriate, the following general rules shall apply:

1. Participants

The contest is open to all Grades 10, 11, and 12 students enrolled in any public and private elementary schools nationwide. The school should be duly recognized by DepEd.

2. Theme and Content

- 2.1 The song composition must fully describe *KAGITINGAN* through this year's theme: "**KAGITINGAN NG MGA BETERANO, INSPIRASYON NG NAGKAKAISANG PILIPINO.**"
- 2.2 The **song entry** must have a **minimum** duration of **three (3) minutes** and a **maximum** of **four (4) minutes**.
- 2.3 The lyrics and melody of the song should be original.
- 2.4 The song must not contain any vulgar, inappropriate, or offensive language.

3. Criteria

3.1 Music	Creativity, Originality, Arrangement	50%
3.2 Lyrics	Content, Cohesiveness, Prose (structure)	30%
3.3 Overall Appeal	Concept, Impact, Recall	15%
3.4 Interpretation	Artist/ Musicality	5%
Total -----		100%

4. Determination and Announcement of Winners

The contestant who will get the highest score shall be declared as the National Champion, the contestant with the second highest score shall be declared as the first runner-up, and the contestant with the third highest score shall be declared as the second runner-up, so on and so forth.

The names of the winners and process on claiming their prizes will be announced during the symposium.

5. Submission of Entries

- 5.1 The deadline for the submission of entries will be on **March 31, 2022** at **5:00 p.m.** Submission beyond the stated time shall be disqualified.

- 5.4 The entry must be submitted in mp4 format properly labeled/titled together with the music sheet, lyrics, entry form and bio-data of composer.
- 5.5 An email shall be sent to the intrants informing them that the entry has been received and if the entry has been officially accepted for the competition. The organizers shall not be responsible for late, lost, damaged and misdirected entries.
- 5.7 Once submitted, all entries become the intellectual property of the PVAO, whether or not the song becomes the winning piece.
- 5.8 In the event that all entries are deemed lacking or inappropriate, a call for more entries shall be made and final judging may be reset.

6. Prizes

Winners for this year's competition will get cash prizes, plaques and certificates subject to the approval of the management and to the usual PVAO accounting and auditing rules and regulations.
