- 2. This Memorandum shall serve as the designation of the members and secretariat of the Division ACC.
- 3. The Division ACC shall have the following functions:
 - a. Provide inputs to the Regional Office and the Central Office in the formulation of anti-corruption policies;
 - b. Implement anti-corruption policies, programs, and activities issued by the CO, RO, and the SDO, and provide feedback on said implementation;
 - c. Regularly submit corruption incident reports to the Central Office, through the Regional Office;
 - d. In accordance with national policies and standards, conduct public information campaigns to generate support for the anti-corruption programs
- 4. The functions of the Chairperson, Vice-Chairperson, Committee Members and Stakeholder Representative are stipulated in the said DepEd Order.
- 5. The Division ACC shall regularly submit to the CO ACC quarterly reports on the conduct of their respective affairs on the following reporting schedules:

PERIOD	DATE OF SUBMISSION
First Quarter (January to March)	April 15
Second Quarter (April to June)	July 15
Third Quarter (July to September)	October 15
Fourth Quarter (October to December)	January 15
