




1. In line with the Memorandum dated May 27, 2022, re: "1st Director's Cup 22" Tournament of the DepEd-NEU Region III, signed by the Regional Director, DepEd Region III, enclosed hereto are the various members of the committees, officiating officials and other additional information relative to the abovementioned cup.

The event is hosted by the Regional Executive Officers (REO) of DepEd-NEU Region III Chapter, participated by all the SDO-NEU Chapters and the Regional Office chapter, DepEd Region III. The REO, SDO-NEU chapter officers, participants attending the said event shall be on **official business** pursuant to *Article IV Section 3 of DepEd/Dep-NEU 2021 CNA*. While the technical officiating officials (teachers) rendering service shall be granted with **vacation leave credits** pursuant to the provisions of *DepEd Order 53, series of 2003, entitled "Updated Guidelines on Grant of Service Credits to Teachers."*

Each SDO-NEU chapter shall be granted an advance amount of Twenty-Five Thousand Pesos (Php 25,000.00) for their uniform expenses and it shall be deducted from their corresponding share/s that will be downloaded to them.

A. The events shall be divided into 4 clusters, to wit:

Cluster 1 is composed of the Schools Divisions of Nueva Ecija (SDONE), Aurora, San Jose City, Nueva Ecija, Science City of Munoz and Cabanatuan City.

Cluster 2 is composed of the Schools Divisions of Tarlac Province, Tarlac City, Gapan City, Mabalacat City, and Angeles City.

Cluster 3 is composed of the Schools Division of Zambales, Bataan Province, Balanga City, Olongapo City, Pampanga Division and the Regional Office.

Cluster 4 are the Schools Division of Bulacan, Malolos City, Meycuayan City, City of San Jose Del Monte, Bulacan, and San Fernando.

The School's Divisions of Nueva Ecija, Tarlac Province, Zambales and Bulacan SDO-NEU chapters shall serve as the playing venues and shall take charge with the necessary playing equipment and the billeting of the participants that may opt to stay in the place of the event during the conduct of the tournament, including the officiating officials.

B. ELIGIBILITY

Players must be bona fide members of the DepEd-NEU.

C. REQUIREMENTS

1. Certification of membership signed by the SDO NEU President.
2. Medical Certificate (fit to play) duly signed by the SDO Medical Officer or by a government physician.

D. GROUND RULES FOR BASKETBALL

1. In general, FIBA rules shall applied.
2. Each team shall have a minimum number of 12 players and maximum of 15.
3. The team shall have at least 4 players with the age of forty years old and above.
4. Two (2) players aged 40 and up shall play for 5 minutes from 1st, 2nd, and 3rd quarters, for five minutes each in very quarter, and shall be substituted by another 2 forty up players for the remaining minutes of the quarter.
5. In the 4th quarter, any player can play, even without the forty up.
6. If the team has less than four forty up players, the opposing team shall choose who among the players of the forty up shall play for another 5 minutes of the quarters.
7. Absence of players who are forty years old and above shall be a game disqualification or forfeiture.
8. A player awarded with 2 technical fouls for cursing and conduct unbecoming shall be ejected from the game and shall be suspended for the next game.

E. GROUND RULES FOR THE BADMINTON

To be discuss before the start of the tournament by the TM.

5. Closing ceremony and awarding – July 1, 2022, Regional Office Basketball gym.
