**DIVISION TRAINING FOR FOUNDATIONAL COURSE ON
ADOLESCENT HEALTH CARE**

1. Anent to R.A. 10354 on Responsible Parenthood and Reproductive Health Act of 2012, mandates the institution to deliver a sustainable and age- and development-appropriate reproductive health education and training for educators to create an inclusive and integrated Responsible Parenthood and Reproductive Health Education in formal, informal, and indigenous learning. To continuously support primary care service providers for a friendly and responsive adolescent health care, the School Governance and Operations Division through the School Health and Nutrition Unit shall conduct division training for Foundational Course on Adolescent Health Care on August 8 – 9, 2022 at a venue to be announced later.
2. Objectives of the training are as follows:
 - a. To capacitate the health service providers on Adolescent Health Care;
 - b. To better understand the adolescents on their developmental change;
 - c. To enable more appropriate service provision;
 - d. To maintain healthy learning environment; and
 - e. To improve the implementation of service delivery network.
