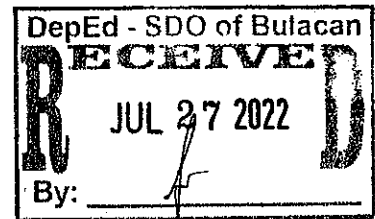



**DATE :** 22 July 2022

The Department of Education engaged the services of Learning Support Aides in SY 2020-2021 to support schools in the implementation of the Basic Education Learning Continuity Plan for responding to the educational needs of the country during the pandemic. Based on DepEd Order 32, s. 2020, LSAs were hired to (1) employ additional workforce to support the delivery of learning modalities; (2) address the need for a stronger relationship between and among school, household, and the community; and (3) ensure unhampered delivery of basic education service.

The Bureau of Human Resource and Organizational Development (BHROD) is spearheading a policy and implementation review of the Learning Support Aides (LSAs). The study includes identification of the roles and responsibilities LSA will perform when schools shift to full face-to-face classes.
