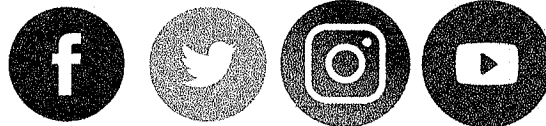

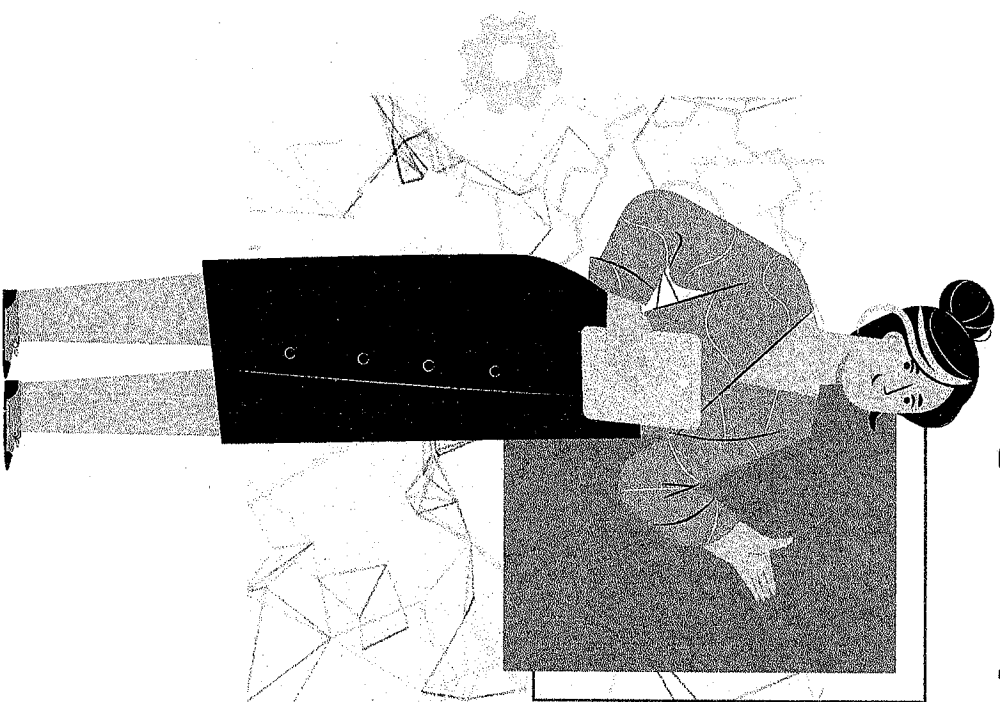

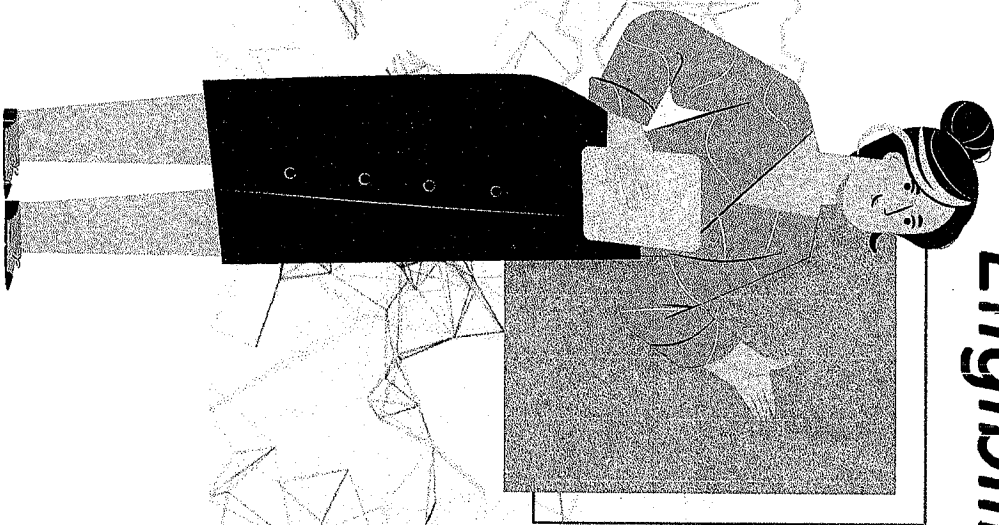


# *Eligibility and Contest Mechanics*



1. The contest is open to High School students from public and private schools in Bulacan Province.
2. The school may endorse one participant only.
3. Registration of participants will be from October 07 to October 13, 2022 via google link <https://forms.gle/dePEVfKcI8TW9R1C8>
4. Each participant shall submit a school ID or any proof of enrollment thru the registration link or via email at [dtibulacan.cpd@gmail.com](mailto:dtibulacan.cpd@gmail.com)
5. All participants shall be admitted in the Zoom meeting room at 1:00PM for the preliminaries and briefing. After the briefing, the contest shall start at exactly 1:30PM. Zoom Meeting Link will be received upon registration.
6. Participants will be given two (2) hours to render their artworks.

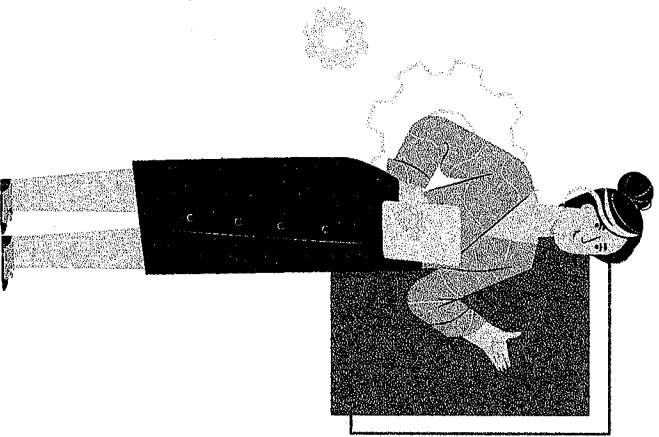
# Eligibility and Contest Mechanics



7. The camera of each participant shall be opened and focused on the artwork and participant during the 2-hour duration of the contest for monitoring purposes and to observe fairness.
8. Medium: Actual drawing using either oil pastel, charcoal, crayons, craypas on  $\frac{1}{4}$  illustration board.
9. Pentel pens are allowed only for outlining and text writing purposes.
10. Theme: Sustainable Consumerism in the Digital Age
11. Criteria for Judging:

Relevance to the theme	- 50%
Originality and Creativity	- 30%
Visual Impact	- 20%
12. Photo of the artwork of each participant shall be taken right after the 2-hour contest duration and submit via email at [dtibulacan.cpd@gmail.com](mailto:dtibulacan.cpd@gmail.com).
13. Screenshots may be taken anytime during the contest proper.
14. Judging of entries and announcement of winners will follow after the contest.

The artist shall submit a written brief explanation of the poster;

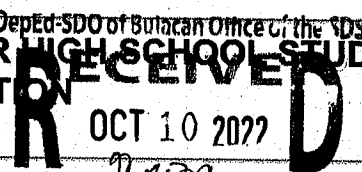

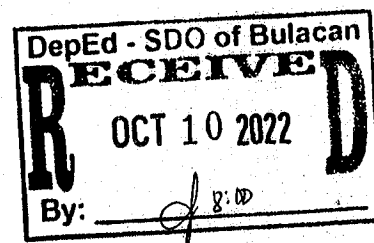
