Pursuant to DepEd Order No. 43, s. 2016 entitled Implementing Rules and Regulations of the Republic Act 10588 or the Palarong Pambansa Act of 2013, the Palarong Pambansa Secretariat shall provide support services to the Palarong Pambansa Board and shall perform other sports-related activities leading to the Palarong Pambansa, as provided in Section 10, Rule II of the therein enclosed IRR of the Palarong Pambansa Act of 2013.

In view of this, this Office through the Falarony Fumbansa Secretariat (PPS), shall conduct the National Refresher Course for DepEd Coaches on the Return to Sports on the following clusters, and the corresponding dates and venues:

The Refresher Course aims to orient participants on the new policies and guidelines on the return to sports; apprise them on how to shape safe and healthy playing environment; and provide updates on the current trends in sports coaching.

The target participants are DepEd coaches, department/school heads, sports club coordinators, and sports officers currently handling sports/varsity teams and/or managing sports programs. The participants must meet the following qualifications/requirements to participate to the activity:

- a. Must be physically fit. Pregnant women are discouraged to participate;
- b. Equipped with the knowledge and expertise of the sports; and
- c. Must be handling sports/varsity team and/or managing sports programs.

Only participants included in the list submitted by the regional offices shall be provided with the online registration link to be sent to their respective email addresses by the *Palarong Pambansa* Secretariat.

The participants are enjoined to actively participate and complete the Refresher Course from the first to the last day of the activity. Failure to complete the course will result to non-issuance of the training certificate.

Participants are likewise encouraged to bring their personal sports equipment/implements such as rackets, arnis sticks, among others.

In observance of and compliance to DepEd Order No. 34, s. 2022 entitled School Calendar and Activities for the School Year 2022-2023, the schools division offices, through the school heads, shall ensure that a substitute teacher will take over the class in the absence of their respective teaching personnel who will participate to the Refresher Course to prevent disruption of classes.

Expenses such as food and accomodation, and travel expenses of the personnel of the *Palarong Pambansa* Secretariat and other support staff shall be charged against Physical Fitness and School Sports Fund, white travel expenses of the participants shall be charged against their respective MOOE/local funds, subject to the usual accounting and auditing rules and regulations.
