EXTENSION ON THE SUBMISSION OF DOCUMENTARY REQUIREMENTS FOR APPLICATION OF ADDITIONAL TRACK/STRAND FOR SENIOR HIGH SCHOOL, GOVERNMENT RECOGNITION AND APPLICATION/RENEWAL OF GOVERNMENT PERMIT TO OPERATE FOR SCHOOL YEAR 2023-2024

To: Assistant Regional Director
Schools Division Superintendents
Private Schools Focal Persons
All Others Concerned

1. Pursuant to DepEd Order No. 88 s. 2010, titled *2010 Revised Manual of Regulations for Private Schools and its Amendment through DO 11, s. 2011*, any private school which desires to apply for Government Authority to Operate shall file an application to the Regional Office subject to the approval of the Regional Director.
2. In view of the adjustments made to the School Calendar for School Year 2022-2023, re : DepEd Order 34 s. 2022, titled *School Calendar and Activities For The School Year 2022-2023, particularly Item No. 3* which necessarily means adjustments to the school opening of classes in order to give ample time for private schools to prepare the necessary documentary requirements for the following business processes:
 - a. Application for Government Recognition;
 - b. Application for Government Permit/Renewal;
 - c. Offering of Additional Track/Strand for Senior High School and;
 - d. Application to Offer Special Programs.
3. In line with the foregoing, the Department of Education Regional Office III issues this Memorandum extending the submission of documentary requirements **from October 31, 2022 (RM No. 172 s. 2017) to January 31, 2023.**
4. The said extension only covers schools which opened in August 2022 of the current school year. For schools which opened earlier than August, the old timeline for the submission of documentary requirements would still be in effect. Applications received after the deadline will not be processed.
