CONTRACT AGREEMENT

Printing & Delivery of SY 2022-2023 2nd Quarter Self-Learning Modules for the Grades 7 and 9 Learners of SDO Bulacan (LOT 1)

THIS AGREEMENT made the ____ day of ___ 2022, between **Department of Education- SCHOOLS DIVISION OF BULACAN** of the Philippines (hereinafter called "the Entity") of the one part and **VECO PAPER CORPORATION**, of Concepcion St. Buli, Muntinlupa City, represented by **MR. VICTOR LIM**, President of the other part (hereinafter called "the Supplier");

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly procurement of *Printing & Delivery of SY 2022-2023 2nd Quarter Self-Learning Modules for the Grades 7 and 9 Learners of SDO Bulacan (LOT 1)* and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of *Six Million One Hundred Sixty Thousand Eight Hundred Ninety Six and 30/100 Pesos (Php 6,160,896.30)* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - Philippine Bidding Documents (PBDs);
 - Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Six Million One Hundred Sixty Thousand Eight Hundred Ninety Six and 30/100 Pesos (Php 6,160,896.30) or such other sums as may be ascertained, VECO PAPER CORPORATION, agrees to provide the goods and services and to remedy defects therein in accordance with his/her/its Bid. Delivery of goods within twenty (20) days to commence upon receipt of contract.
- 4. The *Department of Education-Schools Division of Bulacan* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
