WHEREAS, on June 29, 2022 the Department of Education Schools Division of Bulacan through the Bids and Awards Committee (BAC) posted an Invitation to Bid<sup>1</sup> (Annex A) for the rebid of Purchase and Delivery of Medical Supplies for SDO Bulacan at the PhilGEPS with Reference Number 8794043<sup>2</sup>(Annex B), a two-lot project with a total ABC of One Million One Hundred four Thousand Three Hundred Ninety Peso (Php 1,104,390.00).

WHEREAS, there were nine (9) interested bidders who acquired the bidding documents and during the Opening of Bids held on July 19, 2022 at the Conference Hall of SDO Building, submitted offers, the bidders namely:

1. KNG Pharmaceutical Supply
2. LEAN & PYKES Pharmacy - *Failed for non-attachment of Certificate of Final Acceptance*
3. Erlyn Enterprises
4. Elite Choice Enterprises
5. Pre Ans Enterprises
6. ARB Pharmaceutical

WHEREAS, except for LEAN & PYKES Pharmacy who failed in the technical components of its bid, *all* bidders *passed* the assessment of both the technical and financial eligibility requirements as expressed in the Abstract of Bids as Read<sup>3</sup> (Annex C) and declared "responsive" upon bid evaluation and post qualification<sup>4</sup> (Annex D);

WHEREAS, based on the detailed evaluation report and as calculated, the bid of KNG PHARMACEUTICAL SUPPLY was declared to be the "*lowest calculated and responsive bid*" (LCRB) however, KNG Pharmaceutical in its letter dated July 23, 2022 claimed incapability to deliver the required volume of the product subject of procurement and sought to reconsider a brand

counterpart to which the Head of the Procuring Entity denied as embodied in its letter of reply dated August 5, 2022<sup>5</sup> (Annex E);

WHEREAS, as provided in RA 9184 and its 2016 IRR, should the bidder with the lowest calculated responsive bid was unable to enter into a contract, for justifiable reason, the bidder ranked with the next lowest responsive calculated bid shall be subjected to post-qualification as with this case, thus, PRE-ANS ENTERPRISES was post-qualified and found to be responsive of all the requirements of the project;

NOW, THEREFORE, based on the above premises, WE, the members of the Bids and Awards Committee, hereby RESOLVE as it is RESOLVED to recommend the award of contract for the Provision of Multivitamins under the School Based Feeding Program to :


