to KNG PHARMACEUTICAL*
(Project No. PB-22-008)

WHEREAS, on June __, 2022 the Department of Education Schools Division of Bulacan through the Bids and Awards Committee (BAC) posted an Invitation to Bid¹ (Annex A) for the rebid of Purchase and Delivery of Medical Supplies for SDO Bulacan at the PhilGEPS with Reference Number 8429507²(Annex B), a two-lot project with a total ABC of One Million Two Hundred Seven Thousand Six Hundred Eight Pesos (Php 1,207,608.00).

WHEREAS, there were three (3) interested bidders who acquired the bidding documents and during the Opening of Bids held on July 19, 2022 at the Conference Hall of SDO Building, submitted offers, the bidders namely:

Lot 1

1. KNG Pharmaceutical Supply
2. Steritex Medical System
3. MBM3 Trading

WHEREAS, except for Steritex Medical System who failed in the technical components of its bid with its failure to attach certification of project completion to support its SLCC, KNG Pharmaceutical Supply and MBM3 Trading *passed* the assessment of both the technical and financial eligibility requirements as expressed in the Abstract of Bids as Read³ (Annex C) and declared "responsive" upon bid evaluation and post qualification⁴ (Annex D);

WHEREAS, based on the detailed evaluation report and as calculated, the bid of KNG PHARMACEUTICAL SUPPLY has been declared to be "*lowest calculated and responsive bid*" (LCRB);

NOW, THEREFORE, based on the above premises, WE, the members of the Bids and Awards Committee, hereby RESOLVE as it is RESOLVED to recommend the award of contract






