Resolution Recommending Award of the Eight (8) Contracts under the Provision of Nutritious Food Package for Kindergarten to Grade 6 Learners of SDO Bulacan under the School-Based Feeding Program

WHEREAS, on April 22, 2022, the Department of Education Schools Division of Bulacan through the Bids and Awards Committee (BAC) posted the Invitation to Bid¹(Annex A) for the projects under the Provision of Nutritious Food Package for Kindergarten to Grade 6 Learners of SDO Bulacan under the School-Based Feeding Program, in the PhilGEPS with Reference Number 8619490²(Annex B);

WHEREAS, said procurement activity is composed of eight (8) separated projects on per lot basis with a total Approved Budget for the Contracts of Twenty Eight Million Three Hundred Seventy Nine Thousand One Hundred Sixty Pesos (Php 28,379,160.00);

WHEREAS, the ABC of Lot 1 is Three Million Four Hundred Seventy Nine Thousand Seven Hundred Sixty Pesos (Php 3,479,760.00), Lot 2 is Three Million Seventy Seven Thousand One Hundred Sixty Pesos (Php 3,377,160.00), Lot 3 is Three Million Five Hundred Three Thousand Pesos (Php 3,503,520.00), Lot 4 amounts to Three Million Seven Hundred Eight Thousand Seven Hundred Twenty Pesos (Php 3,708,720.00) and for Lot 5, Three Million Five Hundred Twelve Thousand One hundred Sixty Pesos (Php 3,512,160.00); for Lot 6 the ABC is Three Million One Hundred Seventy Six Thousand Two Hundred Eighty Pesos (Php 3,176,280.00) and for Lot 7, the ABC is Three Million Eight Hundred Thirty-Three Thousand Four Hundred Sixty Pesos (Php 3,833,460.00 and the ABC of Three Million Seven Hundred Eighty Eight Thousand One Hundred Pesos (Php 3,788,100.00) for Lot 8;

WHEREAS, a pre-bid conference³(Annex C) was held on May 2, 2022 at 2:00 P.M., attended by the Bids and Awards Committee, TWG, BAC Secretariat and five potential bidders; and during which the standard public bidding procedure was discussed and made clear the technical specifications required of the projects to be bid;


