**Resolution Recommending Award of Contract for the Printing & Delivery of SY 2022-2023 2<sup>nd</sup> Quarter Self-Learning Modules (SLM) for Grades 7 and to 9 Learners of SDO Bulacan**

WHEREAS, on August 2, 2022, the Department of Education Schools Division of Bulacan through the Bids and Awards Committee (BAC) posted the Invitation to Bid<sup>1</sup>(Annex A) for Printing & Delivery of SY 2022-2023 2<sup>nd</sup> Quarter Self Learning Modules for Grades 7 to 9 Learners of SDO Bulacan in the PhilGEPS with Reference Number 8878152<sup>2</sup>(Annex B);

WHEREAS, said procurement activity is a 4-lot project with an ABC of Seventy Million One Hundred Seventy Four Thousand Pesos (Php 70,174,00.00.00) with Lot 1 having an ABC of Seventeen Million Four Hundred Thirteen Thousand Five Hundred Pesos (P 17,413,000.00) ; Seventeen Million One Hundred Fifty Seven Thousand Pesos (P 17,157,000.00) for Lot 2; Seventeen Million Eight Hundred Fifty Five Thousand Five Hundred Pesos (P 17,855,500.00) for Lot 3; and Seventeen Million Seven Hundred Forty Eight Thousand Pesos (P 17,748,000.00);

WHEREAS, there were three (3) interested bidders who acquired the bidding documents for Lot 1, four (4) for Lot 2, four (4) for Lot 3 and five (5) bidders Lot 4 bid documents;

WHEREAS, during the opening of bids on August 22, 2022 at 9:01 o'clock in the morning, a total of sixteen (16) bids were received, three (3) bid entries for Lots 1, four (4) bid entries for Lots 2 & 3 and five (5) bid offers for Lot 4:

WHEREAS, the bidders who *passed* the assessment of both the technical and financial eligibility requirements<sup>3</sup>(Annex F) were post-qualified and declared responsive except for Mexico Printing Company, Inc. who failed in Lots 2,3 & 4;

WHEREAS, upon detailed bid evaluation<sup>4</sup> (Annex G) and post qualification<sup>5</sup> (Annex H), the lowest responsive calculated bids were determined namely: VECO Paper Corp. for Lots 1 , 2 and 3 and Forgems Marketing Co.,Inc. for Lot 4;


