Resolution Recommending Award of Contract for the Printing & Delivery of SY 2021-2022 4th Quarter Self-Learning Modules (SLM) for Grade 4 to 6 Learners of SDO Bulacan

WHEREAS, on February 23, 2022, the Department of Education Schools Division of Bulacan through the Bids and Awards Committee (BAC) posted the Invitation to Bid¹(Annex A) for Printing & Delivery of SY 2021-2022 4th Quarter Self Learning Modules for Grades 4 to 6 Learners of SDO Bulacan in the PhilGEPS with Reference Number 8429392²(Annex B);

WHEREAS, said procurement activity is a two-lot project with an ABC of Twenty One Million Five Hundred Eighty One Thousand Two Hundred thirty Five Pesos and 50/100 (Php 21,581,235.50), with Lot 1 having an ABC of Eleven Million One Hundred Fourteen Thousand Nine Hundred Thirty Five Pesos (Php 11,114,935.00) and Ten Million Four Hundred Sixty Six Thousand Three Hundred Pesos (Php 10,466,300.00) for Lot 2.

WHEREAS, there were seven (7) interested bidders who acquired the bidding documents, five (5) bidders acquired Lot 1 bid documents and seven (7) for Lot 2;

WHEREAS, on February 28, 2022 a virtual conduct of pre-bid was held and during the opening of bids on March 8, 2022 at 9:00 o'clock in the morning, five bidders submitted bid entries: 1) Heritage Printing Press-(*failed the Technical component eligibility for non-attachment of certification of project completion under SLCC*) , 2) Bloombooks Inc. jva. Asian Prime Commodities Corp, 3) Impressionista Publishing (*failed, non-compliant with delivery schedule*), 4) VECO Paper Corp, 5) Mine Printing;

WHEREAS, SEVEN (7) bidders participated in Lot 2: 1) Heritage Printing (*failed the Technical component eligibility for non-attachment of certification of project completion under SLCC*) , 2) Bloombooks Inc. jva. Asian Prime Commodities Corp, 3) Victorious Publication technical, 4) Impressionista Pulishing (*failed, non-compliant with delivery schedule*), 4) VECO Paper Corp. 5) Mine Printing and 6) St. Andrew Publishing;




