**Resolution Recommending Award of Contract for the Printing & Delivery
of SY 2022-2023 1st Quarter Self-Learning Modules (SLM) for Kindergarten
to Grade 6 Learners of SDO Bulacan**

WHEREAS, on June 8, 2022, the Department of Education Schools Division of Bulacan through the Bids and Awards Committee (BAC) posted the Invitation to Bid¹(Annex A) for Printing & Delivery of SY 2022-2023 1st Quarter Self Learning Modules for Kindergarten to Grade 6 Learners of SDO Bulacan in the PhilGEPS with Reference Number 8736524²(Annex B);

WHEREAS, said procurement activity is a five-lot project with an ABC of One Hundred Nineteen Million Three Hundred Ninety Thousand Three Hundred One Pesos and 50/100 (Php 119,390,301.50) with Lot 1 having an ABC of Twenty-Three Million Seventy Three Thousand Three Hundred One Pesos and 50/100 (P 23,073,301.50) ; Twenty- Four Million Thirty Seven Thousand Five Hundred Pesos (P24,037,500.00) for Lot 2; Twenty-Three Million Nine Hundred Seven Thousand Pesos (P 23,907,000.00) for Lot 3; Twenty-Six Million Two Hundred Eighty-Five Thousand Pesos (P26,285,000.) for Lot 4 and Twenty-Two Million Eighty Seven Thousand Five Hundred Pesos (Php 22,087,500.00) for Lot 5;

WHEREAS, on June 9, 2022 a pre-bid was held, and on June 27 2022, Bid Bulletin No. 1 was issued changing the date of the opening of bids from June 28, 2022 to June 30, 2022;

WHEREAS, during the opening of bids on June 30, 2022 at 9:01 o'clock in the morning, a total of fourteen (14) bids were received, three (3) bid entries for Lots 1, 2,3 and 5 and two (2) bid entries for Lot 4:

WHEREAS, the bidders who *passed* the assessment of both the technical and financial eligibility requirements³(Annex F) were post-qualified and declared responsive;

WHEREAS, upon detailed bid evaluation⁴ (Annex G) and post qualification⁵ (Annex H), the lowest responsive calculated bids were determined namely: Forgems Inc for Lot 1 , VECO Paper Corp. for Lot 2, Bloombooks Inc for Lots 3 and 4 and St. Andrew Publishing for Lot 5;


