**Resolution Recommending Award of Contract for the Printing & Delivery of 3<sup>rd</sup> & 4<sup>th</sup> Quarter Self-Learning Modules (SLM) for Kindergarten to Grade 10 Learners**

WHEREAS, on December 11, 2021, the Department of Education Schools Division of Bulacan through the Bids and Awards Committee (BAC) posted the Invitation to Bid<sup>1</sup>(Annex A) for the Early Procurement Activity (EPA) of the project Printing & Delivery of 3<sup>rd</sup> & 4<sup>th</sup> Quarter of Self Learning Modules for Kindergarten to Grade 10 Learners of SDO Bulacan, in the PhilGEPS with Reference Number 8291813<sup>2</sup>(Annex B), and in the official SDO website <https://bulacandeped.com>;

WHEREAS, said procurement activity is a seven-lot project with an ABC of Ninety Million Nine Hundred Sixteen Thousand Six Hundred Fifty-Six Pesos (Php 90,916,656.00) intended for the modules to be utilized by learners for the 3<sup>rd</sup> & 4<sup>th</sup> Quarter SY 2021-2022.

WHEREAS, Lots 1,2,3 & 4 are for the printing and delivery of modules for the 3<sup>rd</sup> Quarter of this school year while Lots 5,6 & 7 are for the 4<sup>th</sup> Quarter SLM, allotted with an ABC of Thirteen Million Seven Hundred Forty-Two Thousand Eight Hundred Eighty Eight Pesos (Php 13,742,888.00) Lot 1, ABC for Lot 2 is Thirteen Million Seven Hundred Forty Million Pesos (Php 13,740,000.00), Lot 3 is Thirteen Million Eight Hundred Ninety Seven Thousand Pesos (Php 13,897,000.00), for Lot 4 it's Thirteen Million Six Hundred Forty Thousand Two Hundred Eighty Pesos (Php 13,640,280.00), for Lot 5, the ABC is Ten Million One Hundred Eighty Three Thousand Five Hundred Pesos (Php 10,183,500.00), for Lot 6, it's Thirteen Million Seven Hundred Fifty Seven Six Hundred Eighteen Pesos (Php 13,757,618.00), and Eleven Million Nine Fifty Five Thousand Six Hundred Fifty Pesos (Php 11,955,650.00) ;

WHEREAS, there were four (4) interested bidders who acquired the bidding documents for Lots 1,2 & 3 and three (3) bidders for Lot 4, five (5) for Lot 5, five (5) for Lot 6 and seven (7) bidders acquired the bidding documents for Lot 7;

WHEREAS, during the opening of bids on December 28, 2021 at 10:00 o'clock in the morning, there were four bidders who submitted bids with Forgems Marketing Co. Inc., declared failed in the technical components for not having a notarized certification of ownership; with the same bidders for Lot 2, Forgems Marketing Co.,Inc, was declared failed; four bidders submitted bids for Lot 3 and all four passed initial evaluation; the three (3) bidders for Lot 4 were declared to have passed the technical and financial components of bids; One (1) bidder, Lex Computer Systems failed while the other three(3) bidders passed the initial evaluation for Lot 5; Danrio Enterprises and Lex Computer Systems failed the evaluation of its technical components for Lot 6 while the three (3) other bidders passed the evaluation for Lot 6; and for Lot 7, there were seven (7) bidders who submitted offers, whereas, five bidders passed the evaluation of both its technical and financial eligibility, two (2) bidders, Lex Computer System and Learningway Global Options Corporation failed;

WHEREAS, the bidders who *passed* the assessment of both the technical and financial eligibility requirements<sup>3</sup>(Annex F) during initial evaluation were post-qualified:

WHEREAS, upon detailed bid evaluation<sup>4</sup> (Annex G) and post qualification<sup>5</sup> (Annex H), VECO PAPER CORPORATION was declared as the bid with the "lowest calculated responsible bid" for Lots 1,2 and 3 and BLOOMBOOKS INC., FOR Lots 4,5,6 & 7 as reflected in the attached Abstract of Bids As Calculated<sup>6</sup> (Annex I);

NOW, THEREFORE, based on the above premises, WE, the members of the Bids and Awards Committee, hereby RESOLVE as it is RESOLVED to recommend the award to:


