- 1. Section 5 (b) of RA 6713 titles "An Act Establishing a Code of conduct and Ethical Standards for Public Officials and Employees" states that all heads or other responsible officers of offices and agencies of the government and of government-owned or controlled corporations shall within forty-five (45) working days from the end of the year, render a performance report of the agency or office or corporation concerned. Such report shall be open and available to the public within regular office hours. To adhere with this, this Office shall conduct a post evaluation of Central Luzon Regional Athletic Association (CLRAA) Meet participation and planning meeting for Pre-Palaro and Palarong Pambansa on May 19, 2023, Friday at 1:30PM, at Guiguinto Municipal Athletic & Cultural Center Guiguinto, Bulacan.
- 2. The activity aims to:
 - a. Prepare and check documents to be submitted in the Provincial Government of Bulacan;
 - b. submit the Liquidation Report for the Cash Advances;
 - c. Conduct internal auditing of liquidation report to be facilitated by the Division Accountant and Division AO-IV Property and Supplies; and
 - d. Present the evaluation report conducted by the School Management, Monitoring, and Evaluation (SMME).
- 3. Participants to this activity are SDS, ASDS, Chiefs of CID & SGOD, DSO, ADSO, Delegation/Cluster Chairs, EDDIS Sports Chair, AOIV-Property and Supply, members of the CLRAA 2023 Secretariat/TRMC Committee who served in the recently concluded CLRAA Meet 2023 as well as the Coaches, Asst. Coaches, Chaperons, and the Monitoring & Evaluation Team stipulated in the D.M. 127 and 152, s. 2023. This Communication shall serve as the travel authority of the participants.
