Guidelines on the conduct of Teacher Reflection Form (TRF) Writing in the Elementary Level

- 1. All teacher I applicants are expected to be at the testing school on or before 7:00AM. Likewise, they are expected to bring ballpens and other personal needs for their own provisions.
- 2. Cellphones are strictly prohibited during the entire conduct of the TRF writing which is 45 to 60 minutes.
- 3. Answer sheets are to be provided by the HRMPSB secretariat a day before the test at the Division Office to be secured by the public schools district supervisors.
- 4. A List of Applicants' Code together with the names (25 applicants per list to maintain social distancing and observe health protocols) shall be posted on rooms where the applicant shall take the TRF writing. The said list shall be prepared by the host principal.
- 5. The test administrators/proctors are expected to conduct an orientation on the conduct of the TRF writing before the TRF writing proper.
- 6. At the end of the TRF writing, test administrators/proctors are expected to seal in an envelope the used answer sheets to be submitted to the HRMPSB secretariat before the end of the day. The said envelope shall bear the name of the district, school, number of teacher I-applicants who took the TRF writing with the name of the of the test administrator/proctor.
