3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country






s or regulations of which grant similar rights or privileges to Filipino citizens, ant to RA No. 5183.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before July 25, 2023 at 9:00 A.M. Late bids shall not be accepted.
