Bidders should have completed, within two years from the date of submission and receipt of bids, a contract similar to the Project. - 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country





the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 6. The Department of Education-Schools Division of Bulacan will hold a Pre-Bid Conference on July 14, 2023, at 9:00 A.M. to be held at the Conference Hall, Schools Division Office of Bulacan, Guinhawa, City of Malolos, Bulacan.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before July 25, 2023 at 9:00 A.M. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on July 25, 2023 at 9:01 A.M at the given address below Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
