Signed request from the School Head containing the following documents:

1. Needs analysis reflecting the total enrollment, existing number of usable classrooms, current classroom ratio, and ideal classroom ratio based on the standard parameters of the Department
2. Copy of valid site ownership documents;
3. Actual Site Validation and Assessment Report signed by the Division Engineer with recommendation on the type of school building that can be constructed on the available space within the school OR the scope of repair/rehabilitation to be made on the subject school building;
4. Complete Pre-Detailed Engineering Analysis such as the result of Soil Tests conducted; and
5. Complete Detailed Engineering Designs and Estimates prepared by the Division Engineer
