Anent to DepEd Memorandum OASGFO No. 2022-258 dated October 27, 2022, on the Request for the participation of Learners and Teachers in Extra-Curricular Activities and the Regional Memorandum 621, s.2022 on the Co-Curricular Activities that are allowable to be conducted starting S.Y. 2022-2023, this Office recognizes the importance of the conduct of sports activities among learners from Key Stages 1 to 4. Hence, conduct of sports activities are expected to be held on the 11th week of every quarter (second quarter -January 3 to February 3, and third quarter -April 24 to 28) based on DepEd Order No. 22, s. 2023 on the School Calendar and Activities of SY 2023-2024.
