TRAINING SEMINAR ON GRIEVANCE MACHINERY, ALTERNATIVE DISPUTE RESOLUTION, AND REVISED RULES AND PROCEDURE IN ADMINISTRATIVE CASES

To: Public School District Supervisors (PSDS) School Principals in Secondary Level All Others Concerned

- 1.
