**Invitation to Bid for the Early Procurement of the  
Upgrading and Modernization of School Electrical  
Distribution System at Obando NHS, Obando, Bulacan  
Project No.: PB-23-009**

1. The *Department of Education (DepEd) – Schools Division Office (SDO) of Bulacan*, through the *NEP 2024 – Basic Education Facilities Fund (BEFF)* intends to apply the sum of *Three Million Seven Hundred Eighty-Seven Thousand Nine Hundred Thirty-Eight Pesos and 56/100 (₱3,787,938.56)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *Upgrading and Modernization of School Electrical Distribution System at Obando NHS, Obando, Bulacan, Project No.: PB-23-007*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *DepEd – SDO of Bulacan* now invites bids for the above Procurement Project. Completion of the Works is required *270 calendar days upon receipt of Notice to Proceed*. **Bidders should have completed a contract similar to the Project**. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *DepEd – SDO of Bulacan* and inspect the Bidding Documents at the address given below from *8:00 AM to 5:00 PM*.
5. A complete set of Bidding Documents may be acquired by interested bidders on date and address specified below accomplishing a bidder’s information sheet, payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount specified above to DepEd – SDO Bulacan Cashier.

7. Bids must be duly received by the BAC Secretariat on or before **December 27, 2023, 9:00 am**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **IB** Clause 15.
9. Bid opening shall be on **December 26, 2023, 9:00 am** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The *DepEd – SDO of Bulacan City* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
