1. The Department of Education Regional Office III (DepEd-RO III) supports the agency's strong commitment to **MATATAG Agenda: *Bansang Makabata, Batang Makabansa*** on **TA**ke good care of learners by promoting learner well-being, inclusive education, and a positive learning environment and **GI**ve support to teachers to teach better. Pursuant to Regional Memorandum No. 30. S. 2024, a Regional Online Writeshop on the Development of Monitoring Tool for Implementing the Kindergarten Education Program was conducted on January 17-19, 2024.

3. In line with this the DepEd RO III, through the Curriculum and Learning Management Division, shall conduct a **pilot testing** of the developed monitoring tool for the implementation of the Kindergarten Education Program from **January 29-31, 2024 to February 1-2, 2024**.
4. The activity aims to:
 - a. assess how easily kindergarten teachers can navigate and use the monitoring tool to track learner's progress and activities;
 - b. identify technical issues that may hinder the effective use of the monitoring tool in a real-world kindergarten setting;
 - c. understand which features are most beneficial for teachers and identify any additional functionalities that could enhance the tool's effectiveness;
 - d. verify the accuracy and reliability of the data collected by the monitoring tool to ensure that it provides a precise reflection of learners' educational activities;
 - e. collect feedback from kindergarten teachers to gauge their overall satisfaction with the monitoring tool and understand its impact on their teaching practices; and
 - f. determine how well the monitoring tool integrates with existing kindergarten education systems, such as curriculum planning tools or learner information systems.



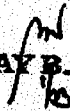

1. Does the monitoring tool have an explicit rationale and details on how recorded responses will be used?			
2. Does the monitoring tool include clear directions for the implementers? Are implementers guided in assessing program implementation?			
3. Can implementers easily answer the items of the monitoring tool based on memory?			
4. Are the items of the M&E simple enough, sufficient, and sufficiently well-defined that all implementers will interpret similarly?			
5. Do the items of the monitoring tool contain any words or phrases that could bias implementers to answer one way over another?			
6. Do the items of the monitoring tool appear to "give away" what the implementers like the responses to be?			
7. Do the items of the monitoring tool focus on a single topic or does it contain multiple topics that should be broken up into multiple questions?			
8. Are all listed response options mutually exclusive? Would it allow more than one answer or include a write-in "other" option?			
9. Do the items in the monitoring tool assess what they intend to assess?			
10. Does the monitoring tool observe correct grammar usage, appropriate vocabulary, and parallelism?			
11. Is the monitoring tool context-specific, appropriate, and culturally relevant?
