CONDUCT OF CAREER GUIDANCE PROGRAM IN THE SENIOR HIGH SCHOOL FOR THE SCHOOL YEAR 2023-2024

- 1. Anent to DepEd Order No. 22, s. 2023, entitled Implementing Guidelines on the School Calendar and Activities for the School Year 2023-2024, item no. 19 discusses the Career Guidance Activities to be conducted to support SHS learners in pursuing their subsequent curriculum exits. In addition, college and middle-level skills fairs, job fairs, business and entrepreneurship expos, and similar activities shall be conducted during the last quarter of the School Year. Hence, this Office reiterates the guidelines on the conduct of Career Guidance Program (CGP) in Senior High School (SHS) for the School Year 2023-2024.

Enclosed is the OUOPS Memorandum 2023-03-8149, Guidelines on the Supervision and Implementation of the DepEd Career Guidance Program for School Year 2023-2024, which set the overall management and implementation of appropriate support and programs for all types of learners in choosing their career paths after graduating from the K to 12 curriculum.
