Coaches from both public and private schools are requested to coordinate closely with the DSAC Over-All Chair Mr. Virgilio Alejandro, School Head of Taal Elementary School, Bocaue District for the preparation and checking of requirements.

All expenses to be incurred relative to the conduct of this activity, like school-based and subsidized training which shall be taken from the support given by Municipal LSB/schools/other sources, and SEF-funded training shall be charged to 2024 Provincial Special Education Funds, subject to the usual accounting and auditing rules and regulations.
